



# **Quick Start Guide – Back Office Matching**

### "A matching process to compare ARCS urgent or scheduled liquidity credits credited to the Funding Account in the prior month with non-cash market messages received by the Lead Managing Agent in the prior month at UMR level. \*"

- A centralised market matching process comparing trust fund FCP movements to claims processed available for lead and follow participants.
- A Finance focused monthly comparison at UMR level of lead provided non-cash market message data with ARCS / STFO processed transfers.
- > Excel format reporting output including UMR level difference analysis.
- > Process oversight and management provided by LIMOSS as part of existing FCP related contractual agreement.
